

Let's start with the +1, since it's top-of-mind today:

### +1. Make improved and expanded CTC permanent

Today, 39 million households — or 90% of kids and their families — began receiving monthly cash payments of up to \$300 per child. **We spoke to four West Virginia working moms about how the money will change their families' lives — at least for the next six months.** It's worth noting that **making the tax cut permanent would benefit 93% of West Virginia's children** — but not a single member of the state's Congressional delegation has signed on. (Yes, we're looking at you Joe Manchin.)

Research shows that <u>an overwhelming majority of voters – regardless of</u> <u>political affiliation</u> – believe that federal policy and budgets should be set according to a "best interest of the child" standard. Prioritize Kids in Policy Making by adopting a children's budget, appointing an Independent Children's Commissioner to identify policy impacts on children, and establishing a Best Interest of the Child standard for federal policy. <u>Read more</u>

End Child Poverty by enacting a national target to cut child poverty at least in half so we can sustain and then build upon progress made on child poverty under the American Rescue Plan. <u>Read more</u>

Improve the Tax Code by making recent improvements to the Child Tax Credit, the Earned Income Tax Credit and the Child and Dependent Care Tax Credit permanent, offering rent relief, and establishing baby bonds for kids' futures. <u>Read more</u>

End Child & Family Homelessness by reforming federal homelessness assistance to meet children's needs, increasing access to affordable housing for families with children, and improving legal protections that prevent evictions. <u>Read more</u>

Ensure Health Coverage for All Children by making the Children's Health Insurance Program permanent, guaranteeing continuous coverage for kids ages 0-5, and expanding health care coverage access for immigrant families. <u>Read more</u>

Improve Child and Maternal Health by providing comprehensive supports to pregnant people, investing in home visiting programs, expanding vaccine access, and training providers in treating childhood trauma. <u>Read more</u>

Restore Environmental Health by pursuing environmental justice for marginalized communities, protecting children from exposure to toxins and lead, and investing in programs that combat the effects of climate change. <u>Read more</u>



# A CHILDREN'S AGENDA FOR THE 117TH CONGRESS

#### EVERY ISSUE IS A CHILDREN'S ISSUE

End Child Hunger and Improve Child Nutrition by strengthening WIC and the Supplemental Nutrition Assistance Program, investing in universal school meals, and expanding access to high-quality nutrition programs. <u>Read more</u>

Protect Immigrant Children & Keep Families Together by guaranteeing children fair immigration proceedings and access to legal protections, prioritizing community-based care, and providing a pathway to citizenship. <u>Read more</u>

Make Child Welfare Work for Kids by improving access to medical and dental care for foster children, addressing racial inequities in the foster care system, and protecting children from the trauma of unnecessary removal. <u>Read more</u>

Restore Justice for Children by fully funding youth-focused equity and prevention efforts, using adolescent development science to inform juvenile justice practices, and phasing out detention and correctional facilities for youth. <u>Read more</u>

**Invest in Educational Equity** by addressing the overcriminalization of students of color and students with disabilities, adequately paying teachers, and expanding career readiness programs and mental health supports. <u>Read more</u>

Prioritize Children in International Policy by updating federal systems for tracking spending abroad, improving early childhood development programs, and promoting girls' well-being and access to education. <u>Read more</u>

Provide High-Quality, Affordable Child Care by increasing pay for early learning educators, funding universal pre-K for three- and four-year-olds, and capping the amount families pay out-of-pocket for child care. <u>Read more</u>

The \$3.5 trillion budget announced yesterday by Congressional Democrats aims to fulfill the President's comprehensive "Build Back Better" investments and items not covered in the bipartisan infrastructure proposal.
